NI-9229 and sbRIO-9229 Specifications

In this document, NI-9229 and sbRIO-9229 are referred to inclusively as NI-9229.

Connector Types

The NI-9229 has more than one connector type: NI-9229 with screw terminal, NI-9229 with snap in terminal, and NI-9229 with BNC. Unless the connector type is specified, NI-9229 refers to all connector types.

Definitions

Warranted specifications describe the performance of a model under stated operating conditions and are covered by the model warranty.

Characteristics describe values that are relevant to the use of the model under stated operating conditions but are not covered by the model warranty.

- **Typical** specifications describe the performance met by a majority of models.
- **Nominal** specifications describe an attribute that is based on design, conformance testing, or supplemental testing.

Specifications are **Typical** unless otherwise noted.
